Annual reporting deadline

Charities with an annual reporting deadline of 31st January 2023 have just under two weeks to submit their annual return to the Charity Commission for Northern Ireland.

Registered charities, which have financial years ending 31 March 2022 and were registered after May 2019, <u>must</u> submit their annual reporting information to the regulator by the end of January - no later than 10 months after the end of their financial year.

While this deadline only affects 140 Northern Ireland charities, there are a further 2,013 charities which were registered by the Commission prior to May 2019 which also have a financial year ending 31st March 2022. Although these annual returns are not legally required, the regulator is encouraging these charities to file their annual reporting information voluntarily.

"Annual reporting is a vital part of the work of each and every charity in Northern Ireland, supporting them in sharing information on their activities and finances with the public, including their own supporters, services users and funders," advised Orla Waterson, Commission Monitoring and Compliance Manager. Charities which wait until the last minute to file their annual return run the risk of not having the right documents or information ready and could end up missing their deadline," she continued.

"In issuing this reminder, I encourage charities to take some time to ensure they have all they need to hand – not only will this help the process go smoothly, but there have also been some recent changes to the annual reporting form they should be aware of before beginning. The recent changes include the addition of six new question areas related to risk areas such as safeguarding, the processing of personal data and fundraising. The return is streamlined by income, with smaller charities required to complete fewer questions than larger charities.

All charities must also now provide contact details for the trustees including their



individual email address and mobile telephone number. This is a key step in the Commission's commitment to communicate and engage better with individual charity trustees in matters relating to their charity.

The Commission has produced new guidance on the annual monitoring return. This is a practical guide that sets out what you need to have to hand before commencing the return, and only takes about 10 minutes to read. 'ARR05 How to complete the Annual Monitoring Return – 10 minute guide' can be found on the Commission's website here.

"Charity trustees often delegate the task of filing the annual return to a single trustee, another person within the charity or to someone external to the charity," Orla added.

"This is understandable but please remember that charity trustees are the ones with the ultimate, overall responsibility. They should be aware of the information requirements within the return, satisfied with the information provided on their behalf and have good oversight that the return is competed and submitted on time," she concluded.

Changes to the Housing Selection Scheme



Changes to the Housing Selection Scheme in Northern Ireland come into effect today.

The Housing Selection Scheme and Common Waiting List governs the allocation of all permanent social housing in Northern Ireland.

It has been in place for more than 20 years and changes are now being introduced to ensure that those in greatest housing need receive priority, with recognition of their time in need.

Jennifer Hawthorne, Director of Housing Services, explained:

"Twenty proposals for change to improve the housing allocation system were identified through the Fundamental Review of Allocations (FRA). Eighteen of these proposals were approved by the Minister for Communities and will be implemented by the Housing Executive in four key delivery stages over three years.

"We are pleased to launch stage one and have written to all households on the waiting list to explain the changes and what this means for them."

Stage one of the FRA change proposals will see the implementation of four proposals:

- An independent, tenure neutral housing advice service for Northern Ireland
- A greater choice of areas for all applicants
- An applicant may receive two reasonable offers of accommodation

 Social landlords may withdraw an offer of accommodation in specified circumstances

Jennifer Hawthorne continued:

"What this means in real terms for those on the waiting list is that they will be able to choose as many or as few areas of choice for a home as they wish. There will also be a reduction from three reasonable offers of accommodation to two.

"Applicants will also benefit from our Housing Solutions Support Service which provides independent tenure-neutral housing advice throughout their housing journey. Customers will be allocated a dedicated housing advisor who will be able to discuss housing options and provide tailored advice and assistance."

"We believe these changes will help to create a better, more efficient service for people in housing need. Customers on the waiting list will receive a letter and information leaflet from us over the coming days however should they wish to speak to someone they can contact their Housing Officer (this may be your Housing Advisor or Patch Manager if you are a Housing Executive tenant or a Housing officer if you are a Housing Association tenant) who will be happy to help."



In November 2020, on the basis of the feedback received, the Minister for Communities announced that 18 of the 20 recommendations would be implemented. The implementation of these recommendations will be phased in, with the first phase being rolled out and operational by the end of January 2023. Carers' Support Fund

The Community Foundation NI on behalf of the Department of Health is delighted to open for application a Carers' Support Fund.

The Carers' Support Fund will provide support for organisations working for and with carers in line with the outcomes set out below.

Grant values of between £2k and £75k will be distributed to properly constituted community groups and voluntary organisations.

Funding awards will fall into 2 broad categories:

- Funding awards of up to £10k
- Funding awards between £10k and £75k

Fund Outcomes

Specific outcomes that the Fund should deliver are:

- a) Enhanced provision of and access to practical support and help for carers.
- b) Improved access to and availability of advice services for carers, including support available through new technologies.

- c) Enhanced skills of carers to advocate for the needs of both themselves and the person they care for.
- d) Support improved physical and mental health and wellbeing of carers.



Northern Ireland

- e) Enhanced ability for carers to lead their own lives and enjoy a work/life balance.
- f) Increased capacity to advocate for and advance carers' issues with government and statutory bodies.
- g) Raised awareness of the contribution of carers.
- h) Improved evidence base on carers to support and inform service provision, and government strategy.

For an application to be successful, it must contribute to one or more of the above outcomes, depending on the level of funding applied for.

Investing in Spaces and Places Grant 2023

Grants are available for small, local groups in the UK to improve community spaces and places where local people can be together and thrive.

Background

Set up in 1988, the ASDA Foundation is Asda's charity. It operates independently of Asda stores but works very closely with Community Champions in Asda's superstores with the goal of building resilient communities by empowering local groups to make a positive difference.

The Foundation offers a number of grants programmes at different times throughout the year, providing more than £3 million to Asda communities.

Objectives of Fund

This annual fund is aimed at local groups who are working to improve spaces in the heart of their local community.

In 2023, the funding will support bigger community projects within local communities where local people can be together and thrive.

The funding is intended for projects that address at least one of the following categories:

- Building repair
- Building development



Outdoor development.

Projects need to align to at least one of the Foundation's aims:

- Create and/or develop safe and inclusive community spaces for groups to meet and bring people together.
- Create or improve spaces which can be used by a range groups on a regular basis.
- Support groups to deliver long-lasting projects focused on long-term community impact.

Value Notes

The 2023 funding pot is £500,000+ with grants of between £10,000 and £25,000.

The grants can cover between 25% and 75% of the total project costs.

Grants can only be made by cheque.

Who Can Apply

Applications are accepted from grassroots, community-led organisations in the UK,



including registered charities, CICs, companies, unincorporated club or association, small community groups or government entity/public body.

To be eligible, applicants must:

- · Be not-for-profit.
- Have an annual income of less than £250,000.
- Have community groups of people as their end beneficiaries.
- Have a presence locally with work that benefits their local community.
- Have unrestricted reserves below £100,000, unless they can provide an explanation.
- Have a bank account in the group's name and be able to provide proof.
- Have suitable governance to be able to manage the grant.
- Have the ability to report back on progress throughout the project.
- Be able to show clear positive impacts for communities.

Since the Asda Foundation does not accept nominations or applications sent directly from community groups, applications **must** be submitted to a Community Champion from an Asda superstore.

To be eligible, applicants must either:

- Own and have full responsibility for the upkeep and maintenance of the building/space; or
- Have a lease of over five years and full responsibility for upkeep and maintenance.

The funder is looking for groups that are:

- Committed to the community mission.
- People-centred and they promote equality, inclusivity and diversity.
- Efficiently run.
- Locally focused with spaces that are focused on the local community, delivering services and support to multiple beneficiaries.

Eliqible Expenditure

Eligible project costs may include materials, tradespeople and equipment costs.

The funding is for projects that fall into at least one of the following categories:

- Building repairs: for spaces and places which already exist but are in disrepair and therefore limit the usability, safety or level of expectations for other to use the space. Repairs may be external or internal and may be due to age, vandalism, abandonment. Example include but are not limited to repairs to roofs, doors, windows, replacing central heating, upgrading electrical wiring or repairing/replacing plumbing.
- Building improvement or development: to enhance a space already in use. The improvements will enhance the quality of space or give more people/new groups the opportunity to use the space. Examples include but are not limited to new kitchens, improving toilet facilities, extension on a building, developing an unused internal space, improving disabled access and facilities, or security features to keep the space and place secure.
- Outdoor Development: to develop outside space for the benefit of the community, particularly outdoor spaces which benefit everyone and can be accessed by large groups of people. Examples include but are not limited to improving access to a community garden, transforming wasteland into usable space, or upgrading a local play area development/upgrading safety features.

There is a five-stage application process:

- Stage 1 Applications are accepted from 6 February 2023 to 19 March 2023
- Stages 2-4 Internal Asda Foundation review. This will take place from March through May 2023.
- Stage 5 Announcement of the funding from 5 June 2023.

Maximum grant value is £25,000.

The Woodward Charitable Trust - Children's Summer Playschemes

The Summer Play Scheme grant round will open **Monday 6th February 2023**, the online application form will only be available after this date. The deadline is noon on **Friday 31st March 2023**. The Trustees will review summer play scheme applications in May and successful applicants will be informed by the end of June 2023.

Each year the Trustees of the Woodward Charitable Trust set aside funds for summer playschemes for children from disadvantaged backgrounds between the ages of 5-16 years.

Trustees only fund programmes that run for a minimum of 2 weeks or 10 full days or 20 half days across the summer holidays.

Grants can only be paid to registered charities, CICs, CIOs or exempt charities. Preference is given to:

- small local playschemes that provide a wide-ranging programme of activities. Trustees prefer activities that are relatively inexpensive such as crafts and cooking, as well as outdoor activities and sport.
- · schemes that involve a large number of children.

 schemes where past users are encouraged to come back and help as volunteers.

Exclusions

Trustees will not fund:

- trips that are only social such as to a theme park or cinema. Trustees prefer to fund trips that are educational and motivational or relate to the natural environment such as to the seaside or countryside.
- charities whose annual turnover exceeds £100,000.
- overseas projects

Annual Funding Programme 2023/24

Who can apply?

- Non-profit distributing organisations which can demonstrate they require a year-round resource to deliver arts programming.
- Commercial organisations can only apply for support if the proposed programme is primarily for the benefit of the public and where there are plans to re-invest any surplus into a similar programme.
- New applicants to the Annual Funding Programme must have been in receipt of a single award of at least £10,001 from ACNI since 1 April 2020 in order to be eligible for the scheme and must contact the appropriate ACNI arts officer to discuss their application prior to submission and by 5pm on 10 February at the latest. Failure to make prior contact with the Arts Council before submitting an application will render your application ineligible.

Please note that premium payments are made retrospectively on submission of evidence of demonstrated use of the services.

The Fibrus Community Fund

Purpose of the Fund:

The Fibrus Community Fund was established by Fibrus Networks Ltd in 2021. The fund is aimed at addressing digital poverty and exists to support the work of communities across Northern Ireland to provide access to digital technology for the most vulnerable.

We recognise that the most vulnerable in our community can sometimes get left behind when it comes to accessing modern technology, something most of us take for granted.

Having the ability to access the internet can open a range of opportunities for individuals and communities especially when it comes to education, employment and socialising. Formed with one vision; to connect communities across Northern Ireland, the Fibrus Community Fund will offer technology grants to enable people to stay connected, whether it is young people staying connected to online resources for school, or elderly people ordering groceries and video calling family.

Data from the Office of National Statistics in 2019 detailed that, despite how the number of people who can't or don't use the internet, has declined in general since 2012, Northern Ireland continues to have the highest proportion of non-internet users across the UK, at 14.2%. Those who perhaps are already disadvantaged and isolated, are now even more so as a result of the pandemic. The digital divide remains a problem throughout Northern Ireland.

The fund therefore, has a particular focus on supporting grassroots organisations that support older people or young people aged 18 and under.

The Fibrus Community Fund will open in two phases in 2023 in tandem with Fibrus' build programme of new full fibre broadband, with phase one opening in January 2023.

Fund Aims:

The fund is aimed at addressing digital poverty by awarding grants of up to £2,000 to enable local groups and organisations in particular areas, to provide access to digital technology for the most vulnerable in that community, with a particular focus on older people and young people aged 18 and under.

We want the fund to support community organisations who are supporting young people or older people to address the digital divide.

What is Available?

We will offer grants of up to £2,000 for projects to address any gaps that younger and older people might face in their communities, which may include provision of access to technological devices.

- Projects that provide access to enhance connections with others, such as a community-use internet hub, or internet café, etc.
- Provision of internet installation/connection in community facilities for community use.

Project Priorities:

- Focus on the positive contribution of people within the community, and support those most in need of support to use and access digital technologies.
- We want to hear how your community intends to build on the assets within that community, to support those who have faced digital challenges.
- We expect you to focus on the need of your beneficiaries in terms of digital poverty, as well as focus on what is good about your community, and how this project will build on previous successes as a community, and support the beneficiary/beneficiaries in the longer term.

GCN is committed to ensuring that their wind farms, whilst having obvious environmental benefits, also provide significant economic benefits to the local community.

The Cregganconroe Community Benefit Fund is available to local community projects within a 10km / 6 mile radius of the wind farm. Cregganconroe wind farm is based just off the Loughmallon Road, Pomeroy, Co Tyrone. The areas located within a 10km radius of the wind farm are largely rural, having a rugged mountainous terrain within the Sperrin Mountains and comprises dispersed rural settlements including the hamlets and villages of Cappagh, Galbally, Pomeroy, Carrickmore, Kileenan and the Rock.
