#### New laws mean changes for private tenants and landlords

New laws governing private tenancies in Northern Ireland will come into effect from 1st April 2023.

The laws will affect both landlords and tenants within the private rented sector. While tenants are not required to take any action, they are advised to be aware of how the new law will affect them and their tenancies. When the law comes into effect from 1st April, private landlords will be required to take certain actions.

#### From 1st April 2023;

- Landlords must provide tenants with a notice containing tenancy information. This includes for current tenants who have not already received this type of tenancy information;
- Landlords must also provide tenants with a notice of variation when any changes are made to their tenancies;
- Landlords must provide receipts for any cash payment in relation to a tenancy;
- Landlords are only permitted to take or hold on to a tenancy deposit of no more than one month's rent;
- There will be increased time periods for protecting and providing information on tenancy deposits; and
- Failure to protect a tenancy deposit will become a continuing offence, as the previous six month time



barrier to prosecution of tenancy deposit offence has been removed.

In the lead up to the changes, the Department for Communities is making tenants and landlords aware of how it may impact them.

#### Consultation launches on revised regional strategic planning policy for renewable and low carbon energy

The Department for Infrastructure has issued a renewable and low carbon energy for 12 weeks public consultation.



The aim of the review is to ensure that planning policy remains fit for purpose and up-to-date to inform planmaking and decision-taking in relation to renewable and low carbon energy planning applications, while reflecting our commitment to the Energy Strategy and the Climate Change (Northern Ireland) Act 2022, which has established a renewable electricity consumption target of 80% by 2030.

# **Policy and Practice Focus**

The road to gender equality – can equality law reform help?

As we celebrate International Women's Day this week, it's always useful to look back on how far we have come in working towards achieving equality for women in Northern Ireland. There is no doubt we have made significant progress over the last decades. But it is equally important to look forward and ensure we know exactly what still needs to be done.

The introduction of the Equal Pay Act (NI) 1970 and the Sex Discrimination (NI) Order 1976 were major milestones in the road toward equality for women. They were landmark pieces of legislation. They significantly improved protections for women in Northern Ireland, but like so much of our equality legislation they now offer less legal protections than those enjoyed by our counterparts living in Great Britain following the introduction of the Equality Act 2010.

Here in Northern Ireland, we currently have a patchwork of legislation that's showing some significant gaps and inconsistencies. As a result of these gaps, people living here are unable to challenge some types of discrimination because the laws are simply not there to protect them.

As part of the Commission's work on law reform, we have longstanding recommendations but, really, rather than try and mend a patchwork, we would be better to work towards a Single Equality Act, which would move all our discrimination laws forward at once.

A Single Equality Act would strengthen, harmonise, and simplify protections across all the equality grounds. Our legislation could and should be world-leading, taking account of lessons from Great Britain's Equality Act, but also looking to other countries to make sure we meet the best international standards. Learning from others will help ensure effective equality protections for everyone in Northern Ireland, include stronger provisions in relation to sex discrimination and equal pay legislation.

So, what needs to change? As part of our statutory remit, the Commission keeps all equality legislation under review and makes recommendations for change. For example, reforms we wish to see in relation to our sex discrimination legislation include:

- prohibiting sex-based discrimination and harassment by public bodies when carrying out their public functions:
- protecting against combined discrimination such as when an older Asian woman is discriminated against due to a mix of her age, gender and race;
- providing stronger protection for employees against sexual harassment by a third party, such as a customer, clients or visitors.

While looking more broadly at equality legislation that would improve protections particularly for women, it is also important that <u>gender pay gap reporting</u> regulations are introduced – these should be accompanied by a gender pay strategy and action plan. Such a strategy should look at structural factors within society and the workplace, like gender stereotyping; education and career choices; caring roles; and the concentration of women in part-time work, especially where they are at risk of low pay.

Northern Ireland's Employment Act 2016 made provisions for these regulations, as well as a strategy, but due to the lack of a functioning NI Executive we are still waiting for this to be enacted.

So, as we celebrate International Women's Day, please take the time to read our <u>recommendations relating to gender policy positions and more broadly, equality law reform</u>. Let's commit to work together to improve, strengthen and simplify all our equality legislation for the betterment of everyone who lives here.

# Podcast: Fit Homes and rural housing with Kirsty Morrison and Ronnie MacRae - A Scottish Perspective

#### Hybrid fundraising jobs increased by 900% in three years, CloF figures show



# Lea Legraien writes in Civil Society News

Hybrid roles advertised in the fundraising sector have increased by more than 900% in three years while onsite roles have declined by 64%, according to new research.

CharityJob's analysis of recruitment figures showed a huge change in working patterns in the fundraising sector between 2019 and 2022 as organisations have embraced hybrid and remote working.

The Chartered Institute of Fundraising (CloF) asked CharityJob to look at its recruitment data from 2022 and compare it with that of 2019. It found that 52% of all advertised jobs in fundraising in 2022 were hybrid, while a third were onside and 15% remote. In comparison, only 5% of these roles advertised in 2019 were hybrid, 91% onsite and just 4% remote.

#### Shift to hybrid and remote non-managerial roles

The biggest increases in the various ways of working were found in experienced non-manager roles, with an increase of over 900% in hybrid experienced non-manager roles and 480% in remote experienced non-manager roles. According to the analysis, the fundraising sector offers more full-time positions than the charity sector overall. Indeed, the former had 8% more full-time jobs than the latter in 2019 and 9% more last year. In total, the number of junior roles available in fundraising can be compared with the charity sector's, but the base location appears to be "more flexible, including hybrid and remote roles".

Moreover, the fundraising sector has more managerial roles compared with the rest of the charity sector while these offer more flexibility when it comes

to their base location.

#### Pandemic ushered 'opportunities for flexibility'

Ceri Edwards, executive director of people and engagement at CloF, said that Covid-19 "ushered opportunities for flexibility and improved work-life balance", which "changed workplaces for the better and will have ensured many of us remain with charities that have given us better prospects for our careers and a renewed outlook on our working weeks".

"These strides forward are to be welcomed and will undoubtedly make roles more appealing to many. And while we know that a career in fundraising brings huge rewards and a lifetime of impact, it won't always be enough to attract the talent we need to excite our supporters as we connect them with the causes they care about.

"Our focus now must be on ensuring that the advantages new ways of working bring are open to all, are accompanied by a strong focus on wellbeing and professional development; and that together we foster cultures of inclusion and growth for fundraisers wherever they work."

Raya Wexler, co-founder of CharityJob, added: "In a competitive job market, this is a very welcome shift. The move towards more flexible ways of working both opens up fundraising roles to much broader pools of candidates and offers existing fundraisers the optimal conditions to flourish. This means charities have the best chance of securing top talent. "The flexibility and career progression opportunities currently available mean there's never been a better time to start or progress a career in fundraising."

# **Publications**

#### **Health Inequalities Annual Report 2023**

The Department of Health has published the Health Inequalities Annual Report 2023. This publication presents a comprehensive analysis of health inequality gaps between the most and least deprived areas of NI, and sub-regional gaps within Health & Social Care (HSC) Trust and Local Government District (LGD) areas across a range of health indicators.

#### **Key Findings - Regional**

- in 2019-21, male and female life expectancy at birth showed no notable change in NI and its most or least deprived areas. While the male deprivation gap (7.3 years) showed no notable change since 2015-17, the female deprivation gap (5.1 years) widened slightly over the period.
- inequality gaps narrowed for male healthy life expectancy (HLE) and male and female disabilityfree life expectancy (DFLE), following improvements in the most deprived areas. In 2019-21, the most-least deprived gap in HLE stood at 11.2 years for males and 15.1 years for females.
- large inequality gaps continue to highlight
  markedly higher rates of premature mortality in the
  most deprived areas, with the majority of gaps
  showing no notable change over the analysed
  period. Preventable mortality increased in the most
  deprived areas resulting in the inequality gap
  widening with the rate in the most deprived areas
  now treble that in the least deprived areas.
- large inequality gaps continue to exist for mental health indicators. Prescription rates for mood and anxiety disorders increased regionally and for most & least deprived areas between 2017 and 2021,

with the rate in the most deprived areas 66% higher than in the least deprived areas. In 2019-21 the suicide mortality rate in the



most deprived areas was more than double that observed in the least deprived areas.

- alcohol and drug related indicators continue to show some of the largest health inequalities monitored in NI, with rates in the most deprived areas over five times that in the least deprived for deaths due to drug misuse and four times that for alcohol specific mortality.
- in 2021, within the most deprived areas the proportion of births where the mother reported smoking during pregnancy was almost five and a half times the rate in the least deprived areas.
- over the last five years the inequality gap in the proportion of Primary 1 children classified as obese widened from 45% to 93% due to an increase in obesity rates in the most deprived areas while rates in the least deprived areas saw no notable change.

#### **Key Findings - Sub-regional**

The report also highlights sub-regional inequalities around male life expectancy, female life expectancy, sub-regional deprivation related inequalities, drugs and alcohol misuse and alcohol specific mortality and teenage birth rates.

#### Open College Network NI (OCN NI): Centre Learning Grants Programme

Open College Network NI (OCN NI) plans to award a share of £85K to education, voluntary and charitable training providers locally via their Centre Learning Grants Programme, now in its second year.

The Centre Learning Grants Programme, with a closing date for applications of Friday 12th May 2023, was created by the OCN NI Board of Trustees to help fulfil its charitable objectives. Particular emphasis will be given to help those who may be particularly disadvantaged and would not otherwise have had opportunities to engage in education.

This is the first learner funding scheme of its kind in Northern Ireland created by an awarding organisation, explained Martin Flynn, CEO, OCN NI.

"This is the second year of our Centre Learning Grants Programme and if last year is anything to go by, we are expecting another huge response from our very deserving centres. The grants programme provides a unique opportunity for education, voluntary and charitable training providers to apply for much needed additional funding that will help them to innovate and enhance their current offering to support disadvantaged learners locally.

"We will be awarding grants of up to £3,000 for specific projects or activities that advance the mission and vision of OCN NI in a way that provides robust evidence of how learning positively impacts on individuals, families and communities."

Last year, grants were given to the North West Play Resource Centre which received £3,000, the Clanrye



Group was awarded £2,945, People 1st secured a grant worth £2,200, Sacred Heart College received £1,000, Parenting NI received £1,695, Loughan EOTAS received a £2,700 grant and Fermanagh Women's Aid was awarded a Centre Learning Grant of £3,000.

Paul Donaghy Chair of OCN NI, said: "OCN NI is once again delighted to be in a position to 'give back' to learners and training providers through the extension of our Centre Learning Grants Programme.

Over the last 12 months OCN NI has consolidated it's position as the leading awarding body in Northern Ireland so being able to fund and deliver this programme for another year is a key element of charitable function, which aims to ensure the advancement of education for public benefit.

"We have already seen the positive impact from last year's programme to help engage, enrich and equip learners for life, so I would encourage centres to apply as soon as possible for the 2023 programme."

#### **Ulster-Scots Summer Schools Grant 2023**

The Agency has opened its Ulster-Scots Summer Schools Grant scheme.

It is for programmes delivered from 1 July to 31 August 2023 and aims to support community and voluntary groups who wish to deliver a five-day Ulster-Scots Summer School to children aged 7-16 years. There are two options available for groups:

#### Standard Summer School

These provide up to 10 different Ulster-Scots workshops and activities. There will be a maximum eligible funding of two hours for each Ulster-Scots activity (maximum of 20 hours' activity).

#### **Drama Summer School**

Drama tutors may be funded to deliver a week-long programme, finalising in a drama production. In addition, groups may provide a maximum of five Ulster-Scots workshops and activities.

Please note: All summer schools <u>must</u> deliver an Ulster-Scots language workshop.



Groups are encouraged to read the guidelines and eligible costs before completing an application form.

Applications close at 12 noon on Friday 5th May 2023. Late or incomplete applications will be rejected.

#### **McCall Foundation**

The McCall Foundation was established by Mervyn McCall and Wilma McCall. In recent years the fund has focused on supporting projects addressing challenges in social care, as well as providing an annual bursary for engineering students through Queens University, Belfast.

#### Aim of fund

This is a partnership fund between the Hospital Saturday Fund and the McCall Foundation. The aim of the fund is to support the development of new and innovative processes, policies, products or programmes that increase the quality, impact, efficiency and/or affordability of social care.

#### The ARN Foundation Tackling Isolation Fund

The ARN Foundation is an independent Charitable Trust set up with the intent of supporting good causes across Northern Ireland.

The ARN Foundation's Tackling Isolation Fund will support organisations to deliver projects in support of older people affected by the cost of living crisis; and will be managed by the Community Foundation for Northern Ireland.

In June 2022 the Community Foundation met with a number of key stakeholders and called for the formation of an Executive to address the cost of living crisis.

As part of the Foundation's commitment to being flexible and responsive we have agreed to review some of our funds with a view to supporting communities at this time.

Among the hardest hit by the cost of living crisis are older people. Older people are often on fixed income, and the rising cost of food and fuel has often led to having to choose between eating or heating.

The latest cost of living research from Age UK found around 65,000 households aged 60+ in Northern Ireland will have insufficient income to cover their essential spending this year.

Around 25,000 (almost 40%) of pensioners here are currently living in poverty or just above the poverty line.

There are concerns that over the next few months and into the winter that older people will suffer further. In recognition of the needs of older people, the ARN Foundation has developed a new Fund, the Tackling Isolation Fund, with a particular focus on food and fuel.

Groups supporting older people can access up to £10,000 of financial support.

#### **Eligibility**

To be eligible to apply your project must target at least three of the key priorities detailed below:



- Supporting older people to keep warm.
- Supporting older people to access a nutritious meal.
- Reducing isolation and vulnerability of older people through supporting participation in activities.
- Enabling older people to access technology, and to potential benefits and entitlements that they may not be aware of.
- · Beneficiaries who are rurally isolated.

### Examples of projects could include, but are not limited to:

- Supporting older people through delivery of services to live an independent and well-nourished way of life in their own home and as part of the community.
- Providing opportunities for older people to be involved in the design, delivery and ongoing management of community-based initiatives.
- Overcoming social isolation through social contact with other older people building on food activities, such as cooking from scratch and sharing meals, and other activities involving the wider community.
- Promoting intergenerational activities by involving older and younger people in food-based and social activities.
- Providing choice in meeting nutritional needs, including delivery of shopping by volunteers or accompanied shopping, and befriending support.
- Increasing affordability of, and access to, basic foodstuffs and/or fuel.

#### Women and Girls Match Fund

Equality is essential for women and girls to dream freely, achieve proudly and live boldly. #### Eligibility criteria:

- 1. Be a UK-registered charity with a Charity Commission number or tax-exempt status and an annual income of at least £25,000 (as per last filed accounts).
- 2. Charities which are registered on BigGive.org (free to register).
- Charities seeking to raise either £2,500, £5,000 or £10,000 in public donations (to be doubled by the match funds). Charities are able to use the campaign to raise unrestricted funds.
- 4. Charities working to to improve the lives of vulnerable, disadvantaged or underrepresented women and girls within the UK and internationally.
- 5. Charities that are led by, for and with women and girls. To assess this, we will look at whether your governing documents specifically mentions women/and or girls, whether you have a majority



female board, who your beneficiaries are and your web presence (if your organisation has one).

 We would encourage applications from charities that are led by Black and minoritised women and girls, LGBTQI women and girls, or Disabled women and girls. These applications will be prioritised in our assessment process.

#### New 'Food hubs' grant funding available for Community Fridges

Community Fridges bring people together around good food. Across the UK they are reducing social isolation, increasing access to skills, sharing knowledge and repurposing fresh (surplus) food. We know that many groups want to do more, and so in partnership with Starbucks we're offering £7,000 (per group) in funding for up to 50 Community Fridges to develop additional food initiatives.

These additional activities could be skills workshops, growing initiatives, gardening schemes or cooking (to name a few)! So, if you're already running an **open** Community Fridge feel free to apply.

#### What the funding is for:

The funding aims to support the development of new activities relating to cooking, growing, budgeting and using surplus food that fit into one of four themes:

**Skills** – To up-skill your community and raise awareness of sustainable, affordable, and heathy living. E.g. workshops, events, cookbooks, or how-to-guides.

**Affordable food** – To try out new ways to increase access to local and affordable food. E.g. food cooperatives, food box schemes or food markets.

**Community connection** – To provide opportunity for the community to come together around shared food. E.g. community meals, coffee and chats, youth



activities, and recipe shares.

**Growing** – To support community growing and increase the amount of edible food grown and shared locally. E.g. community gardens, greening projects and seed or plant sharing.

Community Fridge groups will be able to apply for funding from 9am 31st March 2023. Applications close 31st May 2023 at 11.59pm.

The Heart of the Community Fund is an open grant round designed to meet the needs of not-for-profit organisations delivering vital services and supports to people across the island of Ireland.


