Christmas is a special time of the year. However, cooking, overloaded electrics and candles all increase the risk of fire within the home at this time of year.

Northern Ireland Fire & Rescue Service would like to ensure everyone has a safe and happy festive season. Please consider the following fire safety advice for keeping you safe this Christmas and New Year.

- Have a working smoke alarm fitted on all levels of your property.
- Never leave cooking unattended and avoid cooking whilst under the influence of alcohol. Make sure cooking appliances are turned off after use.
- Check your Christmas lights are in good working order and conform to the British Standard.
- Never overload sockets and always turn Christmas lights off before going to bed or if you are leaving the house.
- Don't buy fake electrical goods.
- If you are using extra heaters during the winter months, make sure they are kept away from soft furnishings and Christmas decorations.
- Keep candles away from soft furnishings, decorations, Christmas trees and wrapping paper.

Ensure they are out of reach from pets and children. Never leave candles unattended.

- Make sure cigarettes are extinguished correctly and never smoke in bed, particularly if you have been drinking alcohol. Empty ashtrays safely.
- Make a fire escape plan. Ensure any visiting family and friends are aware of the escape plan too; tell them where you keep door keys.
- Keep your escape routes clear; it's easy for exits to get blocked with Christmas trees and presents.
- Check on older relatives and neighbours this Christmas to ensure their safety at this time of year.

Remember, if a fire starts, get everyone out and close all doors behind you. Dial 999 and ask for the Fire & Rescue Service.

Policy and Practice Focus

Charities 'need to know' about the new campaigning code, Commission chair states

Charities need to be aware of the new <u>Non-Party Campaigner Code</u> which comes into effect from 1 December, the chair of the Charity Commission has advised.

Orlando Fraser, chair of the charity regulator, and John Pullinger chair of the Electoral Commission, <u>wrote in a</u> <u>blog</u> that charities "need to know" what this will mean for the charity sector.

"By way of summary, in addition to a charity's continuing obligations under normal charity law, electoral law requires charities to register as non-party campaigners if they spend over a certain amount on regulated campaign activities in the 12 months leading up to the next election," the blog states.

It adds that spending on certain activities is regulated if the activity can reasonably be regarded as intended to influence people's voting choice. Thus, such activity, which is lawful under charity law if it isn't supporting a specified party or candidate, is regulated under electoral law, counting towards your spending limit," the blog reads.

"You will be required to register with the Electoral Commission as non-party campaigners if your charity spends over £10,000 (previously this was over £20,000 in England), on regulated campaign activities, across the UK. After the election, you may then need to provide financial returns to support public transparency," it adds.

The third thing the blog highlights is that the law now requires an imprint to be included on digital material that falls within the definition of regulated campaign activities.

The blog states: "An imprint tells voters who is responsible for publishing and promoting campaign material. This means that many types of digital material such as social media adverts and posts will require an imprint."

'Charities can take part in political activity'

The blog adds that the organisations understand many charity leaders and trustees will see this as a critical moment to speak up for beneficiaries and highlight causes.

"Charities have a proud record of engaging in public debate and campaigning on behalf of their purposes which is entirely legitimate" and doing so consistently with the legal framework is crucial.

"Charities can take part in political activity provided it supports their purpose and is in their best interests. However, political activity mustn't become the reason for a charity's existence. Charities must also remain independent and must not give their support to a political party," it states.

The chairs point to guidance for charities on campaigning and political activity, as well as the social media guidance.

The blog adds: "We understand that these changes can appear daunting. That's why we want to make sure you feel equipped to enter the next election period, undertaking any campaigning to advance your charity's purposes, with confidence.

"We want to stress that electoral law exists not to limit campaigning, but to ensure that there is transparency around key campaigning activity."

Small charity to close after 100 unsuccessful applications to core funding

TAROE Trust will be closing down following a review that identified "unfavourable operating conditions".

The charity's trustees said it had applied to more than 100 potential sources of core funding without success over recent months. Darren Hartley, chief executive of the TAROE Trust, told Civil Society that a number of issues contributed to the decision. These included a lack of available core funding, reduced capital grants, inflationary pressures and increased workforce and material costs for the charity.

The charity's operations will cease at the end of December, and its remaining funds will be redistributed to related charitable causes, <u>a</u> statement from the trustees reads.

Income

Set up in 2013, the TAROE Trust provides free advice and assistance on housing issues to disadvantaged people and is a representative organisation for tenants in England. The charity only employed one member of staff on a part-time basis, chief executive Hartley, who says he has secured another role for when the charity closes. According to the charity's accounts for the financial year ending March 2023, it had a total income of over £63,000. This fell from £72,000 the previous year. In 2020, the charity received a reported $\underline{\text{\pounds210,000}}$ cash injection from Fusion 21. The charity's chair Michael Gelling described it as a "lifeline".

Indeed, before the donation the charity had a total income of just over £10,000 for the financial year ending 2020. This July, Gelling told Fusion 21 that its recent achievements had only been possible due to the funding and that TAROE Trust's <u>"standing in the sector and our potential for future impact is now very strong.</u>"

'Disappointed and saddened'

Chair of the TAROE Trust, Gelling, said: "I am truly disappointed and saddened that we have had to call it a day on the activities of TAROE Trust. It brings to an end a long tradition of tenant primacy."

He continued: "We hope that our closure will highlight the gap that exists at a national level for a body that represents the interests of tenants from a tenants' perspective.

"The failure of successive governments to fund an independent national tenant body lets tenants down at a time when the need has never been greater. We hope that one day steps can be taken to rectify this failure."

Committee Proposes Raft of Measures to Stabilise Stormont



- Call for NI Assembly Speaker to be elected by twothirds majority of MLAs.

A new report by the Northern Ireland Affairs Committee into the effectiveness of the institutions of the Belfast/ Good Friday Agreement has issued a raft of proposals aimed at restoring and stabilising Stormont.

Among the measures are calls for the UK Government to urgently reform the Assembly Speaker election rules so that a candidate can be elected by a two-thirds supermajority of MLAs.

The same threshold should be used to elect First and Deputy First Ministers, the report recommends. It adds that in recognition of their equal status, the positions should be rebranded as 'Joint First Ministers' with the position open to any two MLAs of any two parties rather than just the largest parties as is the case today.

Each of these changes would require consultation with the Irish Government as co-guarantors to the Belfast/ Good Friday Agreement as well as the parties of Northern Ireland and would require tweaking the 1998 Northern Ireland Act that came from the Agreement. The Act enshrines power-sharing government and devolution in NI.

Funding to Support Youth-Led Social Action Across the UK

Co-op Foundation, in partnership with Co-op and the #iwill Fund, is offering grants of up to £20,000 for groups to support young activists, campaigners, disrupters, cooperates, and social entrepreneurs to lead social action to improve their communities and build upon Co-op's vision of 'Co-operating for a Fairer World'.

Through the Young Gamechangers Fund, a total of $\pounds600,000$ is available for groups with an income of less than $\pounds250,000$ that are:

- Committed to engaging in long-term projects as part of a network of young gamechangers.
- Focused on creating sustainable positive social change that aims to have a lasting impact on individuals and the wider community.
- Proposing or leading social action work that has a clear purpose.
- Rooted in the Young Gamechangers Fund priorities.

Preference will be given to groups that have previously not had access or experienced barriers to funding, groups that are led by and for marginalised communities, and groups that prioritise youth activism and shared power.



Funding can be used for specific project costs, or core and ongoing cores such as salaries, overheads, or other activities that support the group's work.

There is a two-stage application process. Groups must submit an online eligibility test before being invited to complete a full application.

The deadline for applications is 19 December 2023 (noon).

The Fore is the only open-access funder in the UK offering development funding and strategic support to early-stage charities and social enterprises who have exceptional leadership, innovative idea and cost-effective solutions.

The Fore offers a 'wraparound' package of unrestricted, multi-year grant-funding (up to £30,000) training, skilled volunteers, peer-to-peer networks and impact measurement to UK registered charities, CIOs, CICs, and social enterprises with an annual revenue of less than £500,000 in the previous completed financial year.

The funding is intended to have a transformational impact on the organisations being supported by unlocking exponential growth, sustainability, efficiency or some other major step forward. The unrestricted funding can be used for any purpose, including core costs and capital funding. The grant could help, for example, an organisation grow, increase internal capacity, serve new beneficiary groups, become more sustainable or more efficient, etc. Applications for core costs must show how the funding will move the organisation forward rather than enabling 'business as usual'.

There are three funding rounds each year (Spring, Summer, Autumn).

The next funding round will open for registration at noon on 6 December 2023 and close at noon on 13 December 2023.

Help the Homeless

Help the Homeless are a small charity with limited funds available. Please check carefully that both your organisation and your project meet the criteria before making an application.

CRITERIA

- Your organisation must be registered with the Charity Commission in England, Wales or Northern Ireland or a registered Scottish Charity.
- We are able to help only small charities with an annual turnover of less than £500,000.
- We can only accept applications towards the funding of capital projects. We are unable to accept applications towards running/core costs. Note: we are also unable to consider requests for computers and IT equipment.
- We provide small grants of up to £5,000. We do not consider multi-year requests.

There should be a minimum period of two years between the receipt of a decision or grant from us and making a further application.
