# Share our roads responsibly - Annual road safety appeal from the Department for Infrastructure and PSNI

The Department for Infrastructure (DfI) is reminding everyone of our shared responsibility in 2024 to safeguard our own safety and that of others, however we choose to travel on our roads.

The release of provisional figures today by the PSNI show that 69 people died in road tragedies during 2023.

Reflecting on the loss of life over the year, Dr Denis McMahon, Dfl Permanent Secretary said:

"In 2023, 69 people have had their lives cut short and hundreds more have been seriously injured on our roads. I wish to offer my sincere sympathies to all those who have lost loved ones and to those who endure lifechanging injuries through road collisions.

"Evidence shows that most road deaths are avoidable, as more than nine in ten deaths and serious injuries are due to human error. We all share the responsibility for road safety. So if you are driving, slow down; pay attention and look out for other road users; leave the mobile phone alone; always wear a seatbelt and NEVER ever drink or take drugs and drive."

#### Continuing Dr McMahon said:

"What is particularly shocking this year is the high number of deaths of some of the most vulnerable road users - motorcyclists and pedestrians. 13 motorcyclists and 19 pedestrians have died on our roads this year, which accounts for over 46% of road deaths this year.

"If you are a driver help protect more vulnerable road users by slowing down and paying attention. If you are walking please always be aware of your surroundings and if walking at night please ensure you can be seen. And if you are a cyclist or motorcyclist, please ensure you put your safety first. By each and every road user taking personal responsibility, we are likely to see a reduction in the number of people being killed or seriously injured.

"As we start a new year, please resolve to help prevent collisions and save lives by slowing down and paying attention."

The Department is actively committed to improving safety on our roads and continue to work closely with our road safety partners in the PSNI, the Fire and Rescue Service, the Ambulance Service and many other agencies to deliver a programme of road safety education, engineering and enforcement initiatives.

Chief Superintendent Sam Donaldson from the Police Service of Northern Ireland's Operational Support Department said:

"Reducing deaths and serious injury on our roads is a priority for us and we hope that our new initiative which highlights that people who sadly die on our roads are more than just a statistic, will offer people the guidance and information they need to ensure they always reach their destination safely.

"This number is simply horrific and I appeal to all road users to learn about the steps they can take to keep themselves and others safe on our roads.

"As well as deaths, many people have suffered serious and life-changing injuries, demonstrating that as a society, road safety is something that needs to be taken more seriously.

"The responsibility for making our roads a safer place is one that we ALL share, remember the 'Fatal Five' - don't drink or take drugs and drive; slow down; don't be careless; always wear your seat belt and never use your mobile phone whilst driving."







# VCS Representation on the Children's Social Care Services Strategic Reform Programme – NICVA Call for Nominations \*\*Closing Date Extended\*\*

On behalf of the Department of Health, NICVA is currently seeking nominations for Voluntary Community Sector positions across the Children's Social Care Services Strategic Reform Programme.

Summary of the selection and appointment process

The Department of Health has appointed NICVA to undertake a selection process to nominate representatives from the Voluntary and Community Sector to the Children's Social Care Services Strategic Reform Programme.

NICVA is now inviting organisations working within the sector to nominate representatives to be considered for a range of positions across the programmes structures.

A total of 27 VCS positions are available, including membership of the Children's Social Care Services Strategic Reform Programme Board and the position of Co-Chair of the Family Support Workstream.

The application process is open from Wednesday 6<sup>th</sup> December 2023 and now closes at 12pm on <u>Friday 26<sup>th</sup> January 2024</u> and voluntary and community sector organisations are invited to consider and make nominations during this period.

Organisations can apply for any number of the available positions (one application is required per position) but can only be represented once on the programme.

A Selection Panel made up of two Voluntary and Community Sector representatives of NICVA's Executive Board and a senior representative from the Department of Health will consider and agree appointment recommendations for each of the 27 positions across the Reform Programme.

The Panels nominations will be based on their assessment of all applications against selection criteria provided by the Programme Board. The Panel will then confirm their nominations to the Chair and Board of the Children's Social Care Services Strategic Reform Programme.

Final decision making on all appointments and the creation of reserve lists for each available position will be made by the Chair of the Programme Board.

It is anticipated that all VCS appointments will be confirmed by late February 2024. We will update this timeline, if and when more information becomes available.

What is the Children's Social Care Services Strategic Reform Programme.

The Children's Social Care Services Strategic Reform Programme is seeking to deliver reform within children's social care services to address a range of known service challenges, particularly in relation to the increasing volume and complexity of case work. It is also seeking to draw together a number of strands of ongoing reform work, including the Regional Care and Justice Campus Programme and workforce-related reform.

#### **Reform Structures**

The Children's Social Care Services Strategic Reform Programme Board ('the Board') is responsible for providing strategic oversight, direction & governance for the delivery of the reform programme. It ensures that a robust programme plan (supported by workstream plans) is in place and is monitoring progress of the workstreams against the plan.

The role of the Board is to:

- Provide overall strategic direction for the programme;
- Promote co-ordinated activity and collaboration within and across organisational boundaries;
- Ensure the required resources are available;
- Monitor progress against agreed milestones, providing support and challenge, as necessary;
- Advise on contingencies and counter-measures to mitigate the impact of any potential risks to progress; and
- Expedite decision making should implementation issues require escalation.

## Northern Ireland Housing Executive - Building for the future

The Northern Ireland Housing Executive has cut sod on its first housing development in nearly 25 years.

The scheme will see six semi-detached dwellings built at Sunningdale Gardens, North Belfast by construction company, GEDA. Part of a new build pilot, the six homes will be built using Modern Methods of Construction (MMC) and ultra-low energy building techniques, to Passive House standard.

NIHE Chief Executive, Grainia Long said: "We are excited to see work begin on these modern homes which we hope will offer a blueprint for the future of social housing. We are not just building new homes for our tenants for the first time in a generation. We are building future-proofed homes that will be constructed to a standard beyond that of current building regulations in Northern Ireland.

"Making sure our tenants have homes that are safe, warm and dry is always our priority and this pilot pairs that with our commitment to reaching net zero. The ultralow energy building methods being used to construct these houses will mean that our tenants benefit from improved energy efficiency and a reduction in carbon emissions, lower heating bills, savings from reduced fuel costs and more comfortable homes. This pilot will also give us the opportunity to explore the practicalities of returning to building homes as part of the revitalization of our organization."

Construction on site will begin immediately.

Ms Long continued: "We are keen for work to get underway so that people on the waiting list can benefit from these additional homes. It is important for us, as the strategic housing authority for Northern Ireland, to influence the future of social housing and reimagine what estates and housing developments could look like. This scheme will help us to investigate how Modern Methods of Construction can be utilized to deliver much needed homes within a faster timeframe, to a higher level of fabric performance and explore ways to drive down costs, in comparison with traditional construction methods."



NIHE Chief Executive, Grainia Long, Chair of the Housing Executive Board, Nicole Lappin, Construction Director, GEDA Construction, Damian Murray and Department for Communities' Director of Social Housing, Paul Price gathered with representatives from NIHE and GEDA Construction to cut sod on the new build pilot at Sunningdale Gardens, north Belfast.

Construction Director for GEDA, Damian Murray, welcomed the partnership with NIHE and said: "Geda Construction, as prominent social housing builders, are delighted to be involved in this pilot scheme that builds on our long-standing eco credentials.

"Bringing Passive House standards to social housing helps tackle the fuel poverty crisis and aligns perfectly with our Net Zero ambitions. We are looking forward to working with the team at NIHE and our Passive associates, Nilan.Green in making the comfortable and economic attributes of Passive House living achievable for all."

From the Department for Communities, Director of Social Housing Paul Price said: "We're marking the start of this a significant, and welcome, development at Sunningdale Gardens for a number of reasons. Primarily, these homes will help address the need for quality housing which exists in our society. Alongside this, these homes will be built to energy efficiency standards at a time when tackling climate change is a key strand of government policy. So what is happening here won't just provide accommodation for those in need, it will also be more fuel efficient for the residents and have less of an environmental impact overall."

## **Shaping the Future Relationship with Government**

An update from Denise Hayward, VCS Co-Chair of the Joint Forum on behalf of the Voluntary and Community Sector Panel, on proposals for a new Agreement between the Voluntary and Community Sector and Government

The Joint Forum was set up in 1988 to promote regular dialogue between the Voluntary and Community Sector and Departments of the NI Government. The forum is made up of public sector representatives and a Voluntary and Community Sector Panel (VCS Panel) of 15 representatives elected from the sector. The VCS Panel meets with senior representatives from across government and the public sector regularly throughout the year, as the Joint Forum. As an integral part of its workplan for this current Joint Forum term, the Forum's membership has been working on a review of the existing Concordat - an agreement which underpins the relationship and which was last updated in 2011. Former Communities Minster Deirdre Hargey mandated the forum to undertake this review of the Concordat as part of a reset of the Joint Forum in September 2022.

The Forum has taken evidence from across the UK and Ireland about how the relationship between public bodies and the sector works elsewhere and the public policy and legislative frameworks which support these relationships. In the past six months the Forum and in particular the VCS Panel has been shaping a set of values and practices that should underpin these relationships in the future. Our proposals are rooted in recognition of both sectors distinct yet complementary roles in contributing to the social, economic, environmental, and cultural life of Northern Ireland and the belief that by collaborating and working better together, we can increase our impact and agency. Any new Concordat/Agreement should act as a framework for improving partnership working which recognises and supports the contribution each makes to improving the lives of individuals and communities.

On the basis of this mutual understanding of each other's roles, it should be recognised that the VCS sector continues to be a key partner in formulating and delivering many aspects of public policy/ services, and as such, there is a need to develop much stronger partnerships/relationships with government and its agencies. Many VCS sector organisations play a dual role, acting not only as advocates for change or improvement, but also delivering vital service and supports to beneficiaries and communities. A new Concordat/Agreement should recognise the importance of the VCS sector to a healthy, just and prosperous society, and set out

how Government will work alongside and support the sector as a key partner in the years to come.

It should be noted that the VCS Panel is most keen to continue exploring the potential for any new agreement to be given a statutory footing by implementing legislation that would solidify the relationship between the VCS and the Northern Ireland Government and the commitments enshrined in any new concordat/agreement. However, we recognise that this process will take time and we therefore support, in the interim, a clearer link between the new Concordat/Agreement and the Programme for Government and other measures such as a Ministerial statement.

The VCS Panel has begun a process of engagement with the wider sector on these issues via an online consultation event on the 14th November 2023 in preparation for a public consultation by the Department for Communities on the values and principles of a new agreement. This forms part of a wider consultation by the Department on draft proposals for future Infrastructure support of the Voluntary and Community Sector in NI. This consultation launched on 15th November, and we would encourage everyone in the sector to respond to this to help shape and inform these important relationships.

In addition, the VCS Panel will be hosting a series of face to face and online events in January 2024 to engage with the sector in more detail on these issues and to ensure that we represent as wide a range of views as possible in our discussions on final proposals for an agreement between the sectors. More details on these events, including venues etc. will follow in the next few weeks.

# Department launches a Call for Evidence on Planning Policy and Climate Change

The Department for Infrastructure is inviting the public to have their say as a consultation to help inform any future focused review of the Strategic Planning Policy Statement (SPPS) is launched.

The SPPS sets out the regional planning policies for the orderly and consistent development of land here. Given the climate emergency and the Climate Change Act (Northern Ireland) 2022, the Department is looking at how its planning policies can help to reduce carbon emissions, as we collectively chart the path to net zero by 2050. We have seen at first hand the significant impacts of recent flooding events and there is understandably an increased interest in the role of planning policy in responding to our changing climate.

Our planning system plays an important role in helping to address the climate change challenges we will continue to face. We are currently finalising the review of planning policy for renewable and low carbon energy, which was consulted on last year. In addition, we need to consider whether the rest of the SPPS remains appropriate and fit for purpose in relation to climate change. For example, a future focussed review of the SPPS could include a fresh look at the appropriateness of extant policy provisions such as on flood risk, transportation and development in the countryside.

Planning matters affect everyone and the Department is continually seeking opportunities to make positive changes to planning policy which will support the planning system as it shapes our places and communities, delivering for people now and for future generations.



The primary purpose of the Call for Evidence is to engage with stakeholders on the proposed areas of focus for a review of the SPPS and to invite the submission of evidence on the relevant factors that can assist with determining the best way forward.

The consultation will run for 12 weeks until 5.00 pm on Thursday 28 March 2024 and the Department welcomes responses from the public, stakeholders and planning authorities.

The information gathered through the Call for Evidence will be considered by the Department and will help inform any decision by a future Infrastructure Minister on a potential review of the SPPS and the options for it. In the absence of Ministers, any final decisions will be taken in light of the decision-making framework at that time.

# **Policy and Practice Focus**

Report exposes critical links between refugee resettlement and rising rates of UK street homelessness

Centre for Homelessness Impact

A report released by the Centre for Homelessness Impact sheds light on the challenges faced by refugees being resettled in the UK.

Exploring the connection between poverty, education, health inequalities and housing, the report emphasises the role housing plays in shaping the destiny of those on the edge of society. It highlights that refugees bear a disproportionate burden, often facing multiple challenges and disadvantages when trying to find stable accommodation.

Key findings from the report include:

- The correlation between the UK's asylum system and a 223% increase in people sleeping rough after leaving asylum housing.
- Large-scale resettlement programmes, including the Homes for Ukraine schemes, leave people with an increased risk of homelessness due to a lack of support when people leave host households.
- Short move-on periods after asylum application decisions, welfare reforms, the right-to-rent policy, and family reunifications significantly contribute to housing instability for refugees.
- Housing challenges are intricately connected to broader societal issues such as education, health, and employment and refugees face heightened disadvantages in these key areas, impacting their ability to secure and stay in stable homes.

The report, which was written by academics at the University of Huddersfield, delves into statistics revealing a 223% surge in street homelessness for people leaving asylum between June and September 2023. This trend indicates a troubling link between the UK's asylum system and the growing levels of homelessness.

The analysis brings attention to differences in how well different resettlement programmes work. Due to a lack of support during the move from temporary to permanent housing and a lack of appropriate and affordable accommodation, Afghan refugees faced prolonged stays in temporary 'bridging accommodation', while those in the Homes for Ukraine schemes faced a higher risk of homelessness after leaving host families. Looking into why refugees in the UK might end up homeless, the report pinpoints certain factors that may contribute, such as the time it takes to find accommodation after an asylum application, changes in welfare rules, the policy about renting and family reunification. The study shows that people who become refugees through the asylum

process often face more uncertainty and instability when trying to find a stable place to live.

Professor Philip Brown, from the University of Huddersfield and lead researcher on the project, said: "Those people who arrive in the UK to seek sanctuary have, over the last few decades, been increasingly finding themselves accommodated in precarious situations, often enduring homelessness. This is particularly common for those receiving refugee status after a decision on their claim for asylum. These are challenges shared by many people in the UK. A lack of social housing, low-pay work and a poorly resourced support system maintain common struggles. The lack of familiarity with UK systems, difficulty getting into employment and an often fledging grasp of English mean that, for refugees, they find things even harder. We hope that our analysis helps to see where things can be done to help refugees live their lives in peace. Many of these things will help everyone who is struggling to have somewhere safe to call home."

Ligia Teixeira, chief executive of the Centre for Homelessness Impact, said: "This research allows us to better understand the lives of refugees in the UK and highlights the deep personal struggles that people are facing. It's not just about statistics; it's about individuals yearning for stability and security. To truly address this crisis, we must adopt a strategic approach to national and local refugee settlement. "Increasing awareness of rights and providing tailored support are critical for supporting people on their journey towards stability. This involves empowering refugees with knowledge and resources and fostering agency in navigating their new lives."

The report recommends practical measures for the sector. Among these are extending the move-on period, acknowledging the crucial role of social housing providers, and ensuring access to rights-based advice. By providing increased face-to-face support and building capacity within refugee communities, more thoughtful and effective approaches towards refugee resettlement can be created.



#### **Grand Choice 2024**

Local residents or groups in the Castlereagh East area of Lisburn and Castlereagh can apply for up to £1,000 via the 'Grand Choice' participatory budgeting initiative from 15 January 2024.

The key difference between Grand Choice and other council managed funding opportunities is that the successful projects are chosen by the community. The votes of those living in Castlereagh East will decide which projects will be funded.

Councillor Thomas Beckett, Leisure & Community Development Chairman, said: "Once again the council is proud to be supporting this scheme. There is £15,000 available for projects across the council's district electoral area of Castlereagh East. This includes the Moneyreagh, Ballyhanwood, Carrowreagh, Dundonald, Enler and Graham's Bridge areas.

"As with previous rounds of Grand Choice, successful projects can win up to £1,000 and will be chosen by their local community. Voting will be in person at a Community Decision Event on Saturday 9 March in St Mary's Church of Ireland Hall, Ballybeen, 1A Craigleigh Drive, Dundonald from 11am to 3pm. We encourage residents in the Castlereagh East area to use their voting power to select the projects they feel best suit their communities."

Projects that relate to one or more of the Take 5 themes of Connect, Be Active, Take Notice, Keep Learning and Give will be eligible for funding.

All projects must be completed between March and June 2024.

Councillor Alan Givan, Chair of the Lisburn & Castlereagh PCSP, said: "To date Grand Choice has been a great success in all the other district electoral areas with the most recent held in the Castlereagh South area in October 2023. It offers the perfect opportunity for residents, constituted groups and schools to bring a project or event to their local community. If you and a few friends have an idea to support your local community then I would encourage you to consider applying.

"You can apply for up to £1,000 for things such as online or inperson activities, events, tutors, workshops, performers or specialist facilitator. Should you have a specific community issue that needs addressed then you



could request funding for marketing campaigns or equipment for projects. If your group is not constituted you must obtain sponsor support from a local constituted group.

"All applications will be assessed to ensure the project is legal, safe, and achievable within government guidance, the budget and timescale. Our communities have the power to decide where the Grand Choice funding goes.

"Three online workshops have been scheduled to help you decide if your project would be eligible for 'Grand Choice' funds. Please join us and talk to the team who will be happy to answer your questions," concluded Councillor Givan.

# **Boots Charitable Trust Extends Grants Programme to Support Local Communities across the UK**

Boots Charitable Trust is an independent registered charity wholly funded by Boots UK Limited. The Trust recently expanded its grants programme from its home base of Nottinghamshire to across the UK.

Registered charities working in the areas of health, lifelong learning, community development and social care can apply four times a year for grants of between £100 and £10,000. Grants of up to £5,000 are available for smaller voluntary organisations whose income and expenditure is less than £5,000 per year and who are not yet required to register with the Charity Commission.

To be eligible, projects must meet at least one of Trust's four funding priorities:

- Health: Community healthcare, such as homecare or support for sufferers of medical conditions, and health education and prevention
- Lifelong learning: Local literacy and numeracy projects
- Community development: For example, supporting councils in providing voluntary services
- Social care: Personal, social or community activities or schemes.

Additionally, a particular focus within each of these priorities is how the projects demonstrate a commitment to improving diversity,



equality and inclusion within the community.

There is particular interest in projects with the capacity to deliver significant impact and which reach the greatest number of people.

The funding can be used for most expenditure items, including salary and running costs. Large building or construction projects will not be funded, although minor structural improvements and refurbishments would be considered.

There are four application windows per year and applications will only be accepted during the quarterly windows.

## Creative Youth on a Shared Island Programme Invites Applications

Grants are available for sectoral organisations to facilitate projects encouraging creativity among 0-24 year-olds across the island of Ireland.

The Creative Youth on a Shared Island funding scheme seeks to reach children and young people by leveraging the experience and expertise of organisations working in the creative, cultural, arts, community and youth sectors. The primary focus is to encourage collaboration among young people, fostering opportunities for creative engagement across the island of Ireland.

The programme is seeking projects from partnerships that are of significant scale and ambition. Applications must be jointly made with at least one partner based in the Republic of Ireland and at least one partner based in Northern Ireland, with a lead partner identified for the project.

## Cregganconroe and Inishative Community Benefit Fund's are now open

# Cregganconroe Community Benefit Fund Purpose of the fund:

This local community benefit fund was set up by Gaelectric in 2016 and is now managed by CGN Europe – a wind energy and energy storage company that believes in a sustainable future. GCN is committed to ensuring that their wind farms, whilst having obvious environmental benefits, also provide significant economic benefits to the local community.

Cregganconroe wind farm is based just off the Loughmallon Road, Pomeroy, Co Tyrone. The areas located within a 6-mile radius of the wind farm are largely rural, having a rugged mountainous terrain within the Sperrin Mountains and comprises dispersed rural settlements including the hamlets and villages of Cappagh, Galbally, Pomeroy, Carrickmore, Kileenan and the Rock.

The Cregganconroe Community Benefit Fund is administered by the Community Foundation for Northern Ireland.

The Cregganconroe Community Benefit Fund is available for local community projects within a 6-mile radius of the wind farm. Applicant organisations must be located in this area.

#### Cregganconroe Boundary Map

The fund aims to encourage:

- Any programmes/projects that address marginalisation and help tackle rural isolation. In particular, support will be considered for transport solutions that allow a greater sharing of local community resources and to allow for improved mobility for the most isolated.
- Projects that have a particular emphasis on maximising community space by providing minor capital works that bring premises or facilities up to modern standards and in line with current building control regulations.
- Activities/services that are specifically aimed at children and young people and older people; provision of local educational classes/training courses and health related initiatives and arts/cultural activities.
- Projects designed to improve and develop local environmental schemes.
- Priority will be given to beneficiaries within the Pomeroy area given their close proximity to the wind farm.
- Projects that encourage greater cross community interaction at a local level with a focus on improving relations between nationalist and unionist communities in the area. Consideration will be given to activities and events designed to encourage this interaction and cohesion e.g. – Open Days, Festivals and other Community Events including programmes of shared culture, music, sport, drama and dance.

# Inishative Community Benefit Fund Purpose of the fund:

This local community benefit fund was set up by Gaelectric in 2016 and is now managed by CGN Europe

– a wind energy and energy storage company that believes in a sustainable future. GCN is committed to ensuring that their wind farms, whilst having obvious environmental benefits, also provide significant economic benefits to the local community.



The Inishative Community Benefit Fund is administered by the Community Foundation for Northern Ireland. The Inishative Community Benefit Fund is available to local community projects within a 6-mile radius of the wind farm. Priority is given to applicant organisations based within the Carrickmore (3.5 miles), Galbally/ Cappagh (4-5 miles) and Sixmilecross (6 miles) areas.

#### **Inishative Boundary Map**

The fund aims to encourage:

- Stronger more inclusive communities by ensuring that local people have ownership and involvement in the design and delivery of the project.
- Partnership working with community, voluntary and statutory agencies to ensure a coordinated approach.
- Sustainable solutions that address local issues.
- Projects that improve the utilisation of existing community space in each of the above areas.
- Particular emphasis will be placed on funding activities/services that are specifically aimed at older people, people with disabilities, children and teenagers (including pre-school children), providing skills development of local people and promoting health related activities or services.
- Given the remoteness of some of these locations, the isolation and lack of statutory transport provision consideration will be given to local transport initiatives
- Projects and programmes offering invaluable advice and information and signposting on key rural issues e.g. Farm Support Services, Welfare & Benefits and Parenting/Family issues etc.
- Outdoor/Environmental projects will also be considered in terms of encouraging a healthier and active community as well as protecting and enhancing the local environment.
- Finally, wider community events and programmes that encourage greater community interaction (including cross community aspects) encompassing the local rich and varied cultural aspects of music, drama, dance and sport.
- Funding will be considered for costs associated with running/administration costs and for purchasing additional equipment to expand services/activities in each of the areas.
- Priority will be given to projects which demonstrate the ability to collaborate, network and share best practice.

#### Halifax Foundation for NI launch new funding streams

Halifax Foundation for NI have launched their new website and Strategy for 2024 - 2028, 'Better Together' - the following new funding streams are now available;

#### **Community Flex**

This is our main programme which will be a rolling programme, open to registered charities only which have 1 years full accounts published on the Charity Commission website. Maximum grant available £10,000. The charity income in the last 12 months needs to be less than £500,000 (this is a change to our last programme as it was open to those with an income of less than £1m) the charity must support those in greatest need and we can support running costs, salaries, materials, training, transport, activity costs and volunteer costs. Open now!

#### Ignite

This is a seeding grant for new charities, this does not mean newly registered on the Charity Commission website this means set up within the last 2 years -we will check the constitution date for this information. Groups must be on the Charity Commission website. The maximum grant available is £2,000. There is a set budget for this programme and once this has been allocated we will not be able to issue any further grants. There is an option for mentoring or training support with this grant. Open now!

#### Collaborate

This programme is for 2 or more registered charities coming together to tackle a social issue, both charities must have an income under £500k. This programme has a set budget and once this is allocated we will not be able to issue any further funding. Applicants must have a pre-application meeting with the Grants Team before applying online. This is for one year funding only. This programme is open for applications now. Max grant £20k.



#### **Empower**

This programme is <u>not</u> currently open for applications however this will open for funding on 3rd June 24 closing on 28th June 24. Awards will be made in August with a starting date of September.

This is for infrastructure charities supporting community groups to receive 1-2 year funding, maximum grant is £20k. The organisation needs to be a registered charity and must be strategic/ transformational in nature. Projects must not duplicate activities supported by or the responsibility of government departments. A pre-application meeting must take place before applying.

#### 40 Invest

This programme is <u>not</u> open for applications. It's our 40th Anniversary in 2025, to celebrate we will be providing 2 year grants of £40,000 (£20k per year) 10% of this can be allocated as a contingency fund for unexpected expenditure.

This programme opens for applications on Monday 2nd September and closes on Monday 30th September 2024. Awards will be made in December, with a start date of January 2025.

An additional £5,000 we will held for each grantee to support capacity building initiatives. Income must be less than £250k.
