Housing Executive announce energy efficiency investment of £55m

Northern Ireland Housing Executive will invest £55m in energy efficiency measures for their homes over the next year, it was revealed at their annual Sustainability Symposium today.

A ground breaking £9m scheme involving the lowcarbon retrofitting of 300 homes will form part of this investment.

The scheme will see upgrades to 300 homes by March 2025 in the Strabane, Dunmurry, Newtownards, Sion Mills, Dungannon and Antrim areas.

Chief Executive of the Housing Executive Grainia Long, said: "Our Low Carbon Retrofit Programme will deliver a 'whole house' solution with the desired outcome of reducing carbon emissions, lowering householder bills and providing a heathier environment.

"A range of interventions will help us achieve this, including improving energy efficiency measures through retrofitting, the introduction of low carbon heating options like air source heat pumps and the use of renewable energy for power generation and electric storage.

"This exciting programme is just one strand of our £55m investment plan. These plans will help combat the very real pressures created by fuel poverty and the cost of living crisis.

"The low carbon retrofit scheme follows the completion of our first large-scale retrofit programme with EU Interreg funding and match funding from the Housing Executive at over £31m.

"Thanks to this programme, 1400 of our houses are warmer, more energy efficient and have a reduced carbon footprint."

Housing professionals who attended the Sustainability

Symposium at Riddel Hall, Queen's University Belfast, received an update on the latest developments in this programme.

Ms Long also discussed the Northern Ireland Home Energy Conservation Authority annual progress report and attendees heard about Sunningdale, a new build pilot project in north Belfast - the Housing Executive's first housing development for nearly 25 years.

Work on the new build began in November 2023 and construction is now well underway on six semidetached homes, being built using Modern Methods of Construction (MMC) and ultra-low energy building techniques, to Passive House standard.

Other speakers at the event included Ciaran Byrne, Director of the National Retrofit Directorate in Sustainable Energy Authority of Ireland, Angus Kerr, Director of Climate Change, Department for Communities, Dr Inna Vorushylo, Ulster University, and Eddie Murnin, Associate Director of GEDA Construction.

Spring Budget 2024: Key announcements

The Chancellor of the Exchequer, Jeremy Hunt MP delivered his Spring Budget on Wednesday, 6 March . It focused on the economy 'turning a corner' and delivering tax cuts for working people.

The majority of policies were structured with the aims of:

- 1. Creating a fairer tax system
- 2. Supporting people with the cost of living
- 3. Reforming delivery of public services

Announcements made include:

- Reducing National Insurance from 8% to 6% from 6 April 2024.
- Abolishing 'Non-Dom' tax status and replacing the system with new rules from April 2025.
- Extending the Household Support Fund to provide £500 million to families.
- Raising the child benefit charge threshold from £50,000 to £60,000.
- Extending a 5p cut in fuel duty rates for 12 months.
- Investing an extra £2.5 billion of funding for the NHS in England.

As is normally the case with spending announcements in the Budget, devolved regions receive additional money through a Barnett Consequential. In today's Budget, the NI Executive has received an additional £100 million for public services.

Other NI-specific measures:

- One-off regeneration funds of £20 million each for Londonderry and Coleraine as part of the UK Government's Towns Fund.
- £2 million allocation to be spent on "global investment and trade opportunities for Northern Ireland."

NI POLITICAL REACTION

- Northern Ireland Secretary of State Chris Heaton -Harris MP said that the budget "underlines the UK Government's commitment to Northern Ireland and to the Union." He welcomed the £100 million additional Barnett funding for 2024-25, on top of the £3.3 billion spending settlement, as a boost for the Executive's spending power.
- Finance Minister and Sinn Féin MLA Caoimhe Archibald described the budget as a "real



opportunity missed for investment in public services." She said the cut to National Insurance will provide "some relief for workers" but that the additional £99 million the Executive will receive will not "make a dent in the many financial challenges we face."

- DUP Treasury Spokesperson Sammy Wilson MP expressed disappointment in the budget's failure to adequately reward working people, whom he sees as crucial to Northern Ireland and the UK. He said "there is no game-changer in this Budget to show that work pays. Families once again will be seeing more of their income taxed than previous generations yet very little action to tackle the global tax avoiding online corporates."
- Alliance Deputy Leader Stephen Farry MP criticised the Budget, saying it is "shortsighted and irresponsible," as it does not address the economic and social challenges facing the UK, while doing little to help Northern Ireland specifically. He added "this should have been a Budget which addressed the cost of living crisis, boosted declining public services, driven upskilling and delivered a Green New Deal"
- UUP Finance Spokesperson Steve Aiken MLA described the budget as one that "few will be happy with." He said the cut to National Insurance and Barnett consequentials are positive, but that "the real term squeeze on public services will dampen down the stuttering attempts to boost the economy."
- SDLP Leader Colum Eastwood MP said, "a 2p cut in national insurance will be cold comfort to people facing higher prices, higher household bills and a desperate squeeze on public services." Colum Eastwood MP also noted the tangible consequences of budget decisions, such as longer hospital waiting lists, stretched housing waiting lists, declining public sector pay, and underfunding of priority capital projects.

Minister Murphy announces additional £1m of financial support for students

Economy Minister Conor Murphy has announced an additional £1million to support students facing financial hardship as a result of increased costs of living.

The funds will be distributed to Queen's University, Ulster University, The Open University, St Mary's University College and Stranmillis University College for eligible students at those institutions to apply for. Highlighting the additional funding, the Minister said: "I am acutely aware of the impact of cost of living increases on students and am pleased to make this additional £1million available immediately. The support funds are distributed by the higher education institutions to students who find themselves in financial hardship and who, without additional financial support, might not be able to complete their course.

This funding of £1million is in addition to the £2.8million of support funds already committed by the

Department for the Economy this year and is in response to the high level of demand being experienced by the higher education institutions.

The Minister continued, "A thriving higher education sector is

critical for a strong, regionally balanced economy and I am engaging with my officials to fully scope the options for further changes to financial and other means of support. I encourage any student who feels that they may be eligible for additional support to contact their higher education institution and apply. I also urge the institutions to ensure they apply eligibility criteria as flexibly as possible when considering applications for support from students."

Appointments to the Board of the NI Housing Executive

Communities Minister, Gordon Lyons MLA, has appointed Councillor Keith Kerrigan, Councillor Paul McCusker and Councillor Cathal Mallaghan as Board Members of the Northern Ireland Housing Executive (NIHE) with effect from 1 March 2024 until the next local council election

The Minister has also reappointed Mr John McMullan as the Vice-Chair of the NIHE Board from 1 April 2024 to 31 March 2029. Mr McMullan has served as the Vice-Chair from 1 April 2019.

The NIHE was established by the Housing Executive Act (NI) 1971 to take over the housing responsibilities of the 65 separate housing authorities that existed at that time. It is now the overall housing authority for Northern Ireland with a budget of over £740m and a staff of approximately 2,700.

These appointments have been made in accordance with the Commissioner for Public Appointments for Northern Ireland's (CPA NI) Code of Practice. All appointments are made on merit and political activity plays no part in the selection process. However, CPA NI requires the political activity of appointees to be published.

Councillor Kerrigan is a Democratic Unionist Party elected representative in the Derry City and Strabane District Council, and sits on its Policing and Community Safety Partnership Board



Councillor McCusker is an Independent elected representative for Belfast City Council. He sits on number of Council Committees including the Belfast Waterfront and Ulster Hall Ltd Shareholders Committee, is a Member of the Cathedral Quarter Trust in Belfast and founded the charity Peoples Kitchen Belfast.

Councillor Mallaghan is a Sinn Fein elected representative in the Mid Ulster Council, where he is the Group Leader. He sits on the Council's Environment and Planning Committees. He is a director of a local agricultural and farming company, and former Member of the Libraries NI Board Mr McMullan is the former Chief Executive Officer of Bryson Charitable Group, a business he developed from a traditional charity into a modernised fit for purpose Social Enterprise, delivering a range of social purposed services in NI, GB and Rol. He holds voluntary roles on a number of boards including as Chair of Social Enterprise NI and The Bank of England NI Citizen's Panel. He has declared no political activity in the last five years, and he holds no other public appointments.

Could you help restore good governance to a charity?

The Charity Commission for Northern Ireland is adding to its list of prospective trustees who may be called on to provide assistance in a charity either on a short or long term basis – and is looking for interested parties to apply.

Under the *Charities Act (Northern Ireland) 2008*, the Commission has the power to appoint trustees to a charity where it is satisfied there is, or has been:

- misconduct or mismanagement in the administration of a charity
- or it is necessary or desirable to act for the purpose of protecting the property of a charity or for its proper administration.

The Commission may appoint a person to be a charity trustee where, for example:

- there are no charity trustees
- there is a single charity trustee and a need to appoint others for the proper administration of the charity.

Commission staff may also facilitate the introduction of prospective trustees with charities facing particular challenges.

Northern Ireland Labour Force Survey – Young People Not in Education, Employment or Training (NEET)

Statistics on young people who are not in education, employment or training (NEET) were published today by the Northern Ireland Statistics and Research Agency.

Young people not in education, employment or training (NEET)

Young people who were NEET

- There were an estimated 15,000 young people aged 16 to 24 years in Northern Ireland who were not in education, employment or training (NEET) in October to December 2023. This was equivalent to 7.6% of all those aged 16 to 24 years in NI.
- The NEET rate among males aged 16 to 24 was 7.0% and among females was 8.2% in October to December 2023.
- The number who were NEET decreased from the previous quarter and over the year; the quarterly change was statistically significant.
- In October to December 2023 there were an estimated 12,000 young people aged 16 to 24 years



who were not in education, employment or training and who were not looking for work and/or not available to start work (economically inactive). The remainder of those who were not in education, employment or training were looking for work in the previous four weeks and available to start within the next two weeks (unemployed).

The latest LFS reweighting was introduced in February 2024, affecting data from July-September 2022 to September-November 2023, to incorporate the latest estimates of the size and composition of the UK population. Planned Interventions Launch 2024

PIP is funded by the Executive Office (TEO) and administered by the Education Authority(EA). It is a wider commitment of the NI Executive's Community Relations Strategy, <u>Together: Building a United</u> <u>Community (T:BUC).</u>

The Programme provides funding for community and voluntary groups of up to £6,000 to engage up 25 young people aged 9-25 in positive activities and divert them away from anti-social or risk-taking behaviour. Groups may submit up to three applications, though if successful will only be awarded funding for a maximum of three projects. All awards are dependent on the availability of funding from approved budgets.

Previously referred to as a 'summer diversionary' programme, the programme has evolved. Key points to note are:

- Activity is not confined to just the summer period. Groups can deliver projects from June until November, to support interventions covering the Halloween period of 2024.
- Whilst residential activities and trips can be funded, projects can be delivered locally.
- One aim is to improve attitudes of participants towards people in other communities, though cross community engagement is not required under this programme.
- Activities must be delivered at interfaces or engage young people who could potentially become involved in risk taking behaviour at or near interfaces. However 'interfaces' does not just mean physical peace walls and can be anywhere where there is potential for inter or intra community tensions as a result of this risk taking behaviour.
- **EA registration** is not required though encouraged. Groups will need to register a user account with EA online applications portal to apply.

Projects may include activity that:

- enables young people to become aware of their place within the community and look at how they interact with their wider community.
- brings young people into contact with others within their community such as older people, or people from different ethnic or religious backgrounds.
- enables young people to 'give back' to their community through social action such as organising events for others, or a community 'clean up'.
- Raises awareness of the impact of anti-social and risk taking behaviour.
- includes and involves young people in developing positive activity around cultural or commemorative

events.

supports young people to become positive role models for other young people in their community.



Projects can also include additional activities/workshops to meet your own needs e.g.:

- Mental Health awareness
- First Aid
- OCN qualifications
- Leadership programmes
- And most importantly fun activities.

Delivery options can include elements such as team building, residentials, workshops, community events or educational visits. Funding can support transport, staffing, facilitation, equipment, materials, venue hire and more.


