Minister outlines vision for housing ahead of opening new £100m development

Communities Minister Gordon Lyons has set out his priorities for housing, including building more social homes and providing more affordable housing options.

The Minister was delivering the keynote address at the Northern Ireland Housing Conference in the Europa Hotel, Belfast, before attending the opening of the Black Ridge housing development in west Belfast.

Addressing the conference, which brings together a range of organisations from across the housing spectrum, the Minister said:

"Rents and mortgage rates are rising and there is massive demand for private rentals and social housing, yet over the last few years housebuilding has declined. If we want to avoid sliding into a housing crisis, we must deliver the housing we need."

The Minister outlined his intention to make progress in a number of areas.

"We need to build more social homes to address growing housing stress," he said. "We need to deliver more affordable housing options. We need to support people to live independently in their own homes and feel part of their community. We need to provide better quality homes so people can live comfortably and safely. Of course, this work needs to be done at a time when budgets are under pressure across the public sector. However, we have to do it, as otherwise thousands more households and families will struggle to buy a home or pay their rent."

Acknowledging the size of the task ahead, the Minister added: "These issues won't be fixed quickly, or indeed easily. But now, more than ever, we need to work collectively – at all levels of government, with stakeholders, delivery partners and communities – to address the situation we face."

The Minister then spoke before the official opening of the Black Ridge development in west Belfast.



Currently the largest housing development under construction in Northern Ireland, the development will provide 653 new homes, including 549 social homes to rent and 104 affordable homes for sale through shared ownership.

The Minister said: "As Minister, I am pleased to be opening this transformational project. Landmark developments such as Black Ridge are a significant step in addressing the housing need which exists in this community. Everyone has a right to a decent standard of housing. And yet, a home is much more than bricks and mortar. It begins with a roof over someone's head. But it extends far beyond that, into a collaborative effort which supports individuals and families."

The £102m scheme has been supported by £52.4million Housing Association Grant funding from the Department for Communities and £49.4million private finance investment by Apex Housing Association.

The Minister added: "We recognise that houses can be designed and built, but communities are developed and nurtured. And I thank all those here today for giving me the opportunity to share in this event. Schemes of this size and nature are the result of a tremendous amount of work, involving individuals, organisations, communities and government at various levels. I commend Apex Housing Association, and indeed all those involved, and wish the residents every happiness in their new homes."







Insights from Shaping the Future of Voluntary Youth Work in Northern Ireland

In recent weeks, a series of workshops has ignited vital conversations across Northern Ireland, aimed at reshaping the landscape of youth work.

Organised by a committee from across the youth work and play sector and facilitated by NICVA, the workshops have brought over 120 people from across the youth sector together for collaborative discussions envisioning a shared future for the sector.

Supported by funding from the Dormant Account Fund, these in person and online workshops have reflected on current challenges and explored ways to repair, reconnect and transform the sector. Participants emphasized the need for a unified voice, genuine inclusion of youth perspectives, and transparent communication. They recognized the importance of proactive approaches and advocating for the value of youth work.

"I think the value is bringing the whole voluntary sector together to explore what our future looks like and as a voluntary sector do we have a future- is it currently separate or can we be one voice united for the betterment of our children and young people". (participant at Belfast event).

"Young people are the future and if you don't plan it you leave things down to happenstance. I think Northern Ireland is developing in a really unique and exciting way in the next couple of years... it's great to have an opportunity to come together and talk about things". (participant at the Derry event)



Across Belfast, Derry, Lurgan, Ballymena and the online workshops, participants have reflected on the value of collaborating at these gatherings and their desire for collective action.

The energy and optimism evident at the workshops has reaffirmed the appetite for working towards transforming the voluntary youth work sector.

Could you help restore good governance to a charity?

The Charity Commission for Northern Ireland is adding to its list of prospective trustees who may be called on to provide assistance in a charity either on a short or long term basis – and is looking for interested parties to apply.

Under the *Charities Act (Northern Ireland) 2008*, the Commission has the power to appoint trustees to a charity where it is satisfied there is, or has been:

- misconduct or mismanagement in the administration of a charity
- or it is necessary or desirable to act for the purpose of protecting the property of a charity or for its proper administration.

The Commission may appoint a person to be a charity trustee where, for example:

- there are no charity trustees
- there is a single charity trustee and a need to appoint others for the proper administration of the charity.

Commission staff may also facilitate the introduction of prospective trustees with charities facing particular challenges.

To support the Commission in updating its list of prospective

trustees, the Commission is calling for applicants to contact them via email

to <u>admin@charitycommissionni.org.uk</u> (or by post to Charity Commission for Northern Ireland, Marlborough House, Central Way, Craigavon, BT64 1AD) to express their interest and make an appointment to discuss what may be involved.

Applicants are encouraged from all areas of experience; however, previous experience at Board level would be advantageous. For a briefing sheet on the legal requirements and guidance on conflicts of interest, please contact the Commission via the details above. The Charity Commission for Northern Ireland is committed to equality. The Commission encourages diversity and inclusion throughout the charity sector and is keen to improve this in our role as a public body. Expressions of interest are welcome from all eligible persons regardless of religious belief, gender, disability, race, political opinion, age, marital status, sexual orientation or whether or not they have dependants.

An order to appoint a trustee does not constitute a contract between the Commission (or the charity) and the trustee, nor does it create a legal right to remuneration.



Assembly Business

The most recent plenary sessions of the Assembly considered a number of issues including <u>Executive</u> <u>Committee Business</u> comprising the <u>Budget Bill: Consideration Stage</u> and <u>Private Members Business</u> including <u>Waiting Lists</u>: Action Plan and Speech and Language Therapy: Criminal Justice System.

Policy and Practice Focus

Passivhaus Trust sets out recommendations for 'Scottish equivalent' policy implementation



Scottish Housing News

Ahead of the Scottish Government's proposal to introduce design standards for all new build housing to meet a Scottish equivalent to the Passivhaus standard going out to consultation, the Passivhaus Trust has set out its key recommendations for how the policy could be delivered.

In December 2022, the Scottish Government <u>agreed</u> to <u>progress legislation</u> proposed by Scottish Labour MSP Alex Rowley to "introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard, or a Scottish equivalent, in order to improve energy efficiency and thermal performance".

A consultation on the policy is expected in the summer and is due to be adopted as legislation in December 2024.

To support this process, the Passivhaus Trust has recommended that the Scottish Equivalent to Passivhaus should be:

- Introduced into Scotland with a transition period to allow for training and industry preparations.
- Based on the full Passivhaus standard, adapted into a Scottish-owned version that will include localised weather data.
- Designed and built by the existing, local supply chain, with training and support for key sectors (such as ventilation systems) where needed.
- Verified/ certified through Local Authority Verifiers and Section 6 Assessors, who will receive appropriate training to add this to their skills.
- Supported with funding for social housing providers, through a modification of additional supported measures within affordable housing investment benchmarks.

Certified Passivhaus buildings should be accepted as "Deemed to Satisfy" the new regulations from January 2025, to create a positive incentive for the industry to start the transition immediately.

Central to its recommendations is the need for a transition period for the construction industry to prepare for the policy. This is to allow for upskilling and training during a realistic timeframe once the industry has clarity on the exact policy requirements. The Passivhaus Trust is clear that the Scottish Passivhaus equivalent policy should be based on the full Passivhaus standard and its metrics, so that Scotland can benefit from the tried and tested international methodology. As a positive incentive to encourage speedy adoption, the Trust is also suggesting that buildings built to the Passivhaus standard are considered 'deemed to satisfy' Scottish

building regulations from January 2025.

Training in Passivhaus design and construction is readily available in Scotland, but the Trust has also identified a specific additional training need for ventilation system engineers, and training for those involved in certification. To maintain the rigorous quality assurance standards of Passivhaus and embed them into a Scottish context, the Passivhaus Trust is proposing that Local Authority Verifiers and Section 6 Assessors are trained to undertake the quality assurance for the Passivhaus equivalent standard.

To support the transition, the Passivhaus Trust proposes that social housing providers receive additional funding, through a modification of additional supported measures within affordable housing investment benchmarks. In addition, the Trust will encourage and support knowledge-sharing of cost-effective approaches, to help speed up the learning curve process.

Sarah Lewis, research & policy director at the Passivhaus Trust, said: "Scotland is leading the way in developing building standards that will radically cut heating bills, improve indoor air quality and comfort, and deliver quality homes that perform as designed. The Passivhaus Trust is here to support the Scottish Government and construction industry's move towards a Scottish Passivhaus equivalent standard. We have identified numerous ways that we can help the Scottish construction industry through that transition.

"We have been impressed with the can-do attitude of the construction industry involved in delivering Passivhaus schools in Scotland. However, we need time to ensure that the Scottish construction industry is fully prepared and ready to deliver Passivhaus equivalent homes at scale, so have identified that a transition period is essential."

Caitriona Jordan, head of retrofit programmes at Built Environment - Smarter Transformation (BE-ST), said: "Since March 2021, BE-ST has upskilled over 3000 people in Passivhaus standards and the fabric first approach. It is really useful to identify the key training needs for the uptake of a Scottish Passivhaus equivalent policy. It is possible to close the skills gap, train the workforce in Passivhaus, and meet the needs for implementation of the new building regulations at scale. BE-ST is ready to help make that happen."

The Good Relations Indicator report published by The Executive Office today presents a range of statistics relating to community relations, including numbers of hate crimes, attitudinal data on Protestant/Catholic relations and attitudes towards mixing in schools, neighbourhoods and the workplace. publication monitors indicators for the four key priorities of the T:BUC Strategy: our children and young people; our shared community; our safe community; and, our cultural expression.

The Northern Ireland Poverty and Income Inequality Report (2022-23) is released

A publication entitled "The Northern Ireland Poverty and Income Inequality report (2022/23)" has been published by the Department for Communities.

This publication provides estimates of the proportion and number of individuals, children, working age adults and pensioners living in relative and absolute poverty (both before and after housing costs), and other statistics relating to household income and income inequality.

Key facts include:

With the exception of pensioners, poverty estimates have increased in NI in 2022/23 from some historic lows in the previous year. While most of the changes are not statistically significant, the increases in children in relative poverty (before housing costs) and working age



adults in absolute poverty (after housing costs) are. In general, poverty rates in NI seem to be returning to prepandemic levels.

In 2022/23 median household income in NI fell by 5%, compared to a 1% fall in the UK as a whole. As poverty rates are based on household incomes below 60% of the UK median income, this disparity is one of the main drivers behind the increase in poverty levels experienced in NI.

Keeping Adults Safe: Adult Safeguarding Champion and Appointed Person Training

The Adult Safeguarding Champion role combines responsibility for strategy, operations and oversight for an organisation in relation to adults at risk of harm under "Adult Safeguarding: Prevention and Protection in Partnership" (2015) and the "Adult Safeguarding Operational Procedures" (2016). Some organisations will also have Appointed Persons, with delegated responsibility for day to day adult safeguarding operations.

This is a full day's training for Adult Safeguarding Champions and Appointed Persons. It covers:

 The role and responsibilities of the Adult Safeguarding Champion/Appointed Person The safeguarding adults structure for Northern Ireland

- Determining the correct course of action in relation to safeguarding concerns

Funding

Climate Action Fund - Our Shared Future Opens for UK Applications

The National Lottery Community Fund (NLCF) has launched its new £20 million 'Climate Action Fund – Our Shared Values' as part of its wider Climate Action programme.

The funding is for **formal partnership** working across sectors, led by community and voluntary organisations or public sector organisations for projects that reach more people by either:

- Linking climate action to the everyday lives and interests of local communities and inspiring them to take action.
- Influencing communities at a regional or national level, for example by linking up groups across locations, or a campaign that inspires change across one country, or the whole UK.

The funding is intended to reach people who are new to climate action by funding other types of organisations and by using other using people's everyday activities and interests as a starting point for climate action.

For example, a project might:

- Involve people who have not had a say. This could be because they are new to climate action, or because they come from communities that experience poverty, disadvantage and discrimination.
- Introduce a climate perspective to a group who came together around another interest or activity.
- Test the best ways to engage different audiences in climate action.
- Spread an exciting local approach to climate action by sharing it nationally.

There is particular interest in projects that involve people, places and communities



experiencing poverty, discrimination and disadvantage.

Road Safety Trust Accepting UK Applications to Spring 2024 Small Grants Round

The Road Safety Trust, an independent grant-giving trust, supports projects and research that make UK roads safer for all road users.

Public and non-profit organisations across the UK can now apply for the 2024 funding round of Road Safety Small Grants.

This year, grants of £10,000 to £50,000 for up to 24 months is available.

The main aim of the Small Grants Programme is to improve road safety at a local level. The funding is for smaller, local projects with a practical focus. The funder is looking for measurable interventions that link to local priorities and show a proposed link to reducing casualties either directly or through clear interim measures.

Eligible projects are pilots/trials, expanding successful trials across a new area, and/or the evaluation of interventions. Projects should have the potential for being brought to scale, with the ultimate goal of reducing deaths and injuries both locally and across the UK.

Requests for 100% project costs will not be eligible. All projects should have other sources of funding, either cash or in-kind. This contribution can come from the applicant or other partners.

Applications are accepted from local authorities, police forces, fire and rescue services or UK based registered charities, legally constituted not-for-profit social enterprises or community interest companies.

Groups can now book a 1:1 slot with the Grants Team for 9 April or 16 April 2024.



Commenting on the 2024 funding round, The Road Safety Trust's Chief Executive, Ruth Purdie OBE, said:

"The purpose of The Road Safety Trust is to make UK roads safer, achieving impact through the funding of practical measures, research, dissemination and education initiatives.

- The project site must be located within 15 miles of a significant Biffa operation or active Biffa landfill site (check your project's postcode using the Postcode Checker below)

- If the organisation does not own the project site, a fully signed lease with at least 25 years remaining must be in place for Built Environment applications
- There must be a minimum of 104 days of full public access to the project per year
- Any Biffa Award grant must be used for site-based improvement work, not for movable equipment, staff core costs or storage facilities
- Biffa Award is unable to fund requests to help an existing facility meet the requirements of the Disability Discrimination Act
- Biffa Award is unable to fund retrospectively, so you should only apply for funding for work that will take place in the future
- · All shortfall funding must be secured
- Planning permission must be in place, if it is required
- The project must not cross the two themes

Specifically for Natural Environment projects:

- Projects must be working to <u>Biodiversity 2020</u>: A
 Strategy for England's Wildlife and Ecosystem
 Services, it's successor, or a Local Biodiversity Action
 Plan target. See <u>25 year environment plan</u>
- If you are not the landowner you must have a signed landowner agreement in place agreeing to access for maintenance, surveying and monitoring for a period of not less than 25 years
- Research is not eligible
- There must be a comprehensive management plan in place for the key species/habitat(s) involved for each site
- Biffa Award will not fund habitat improvement work on any land which the applicant intends to sell for biodiversity units.
